ref: Central Committee Meeting – 27-28Jul2021 ... **re:** OCF – School Based Official (action item passed)

Presenter: Todd Nelson, NYSPHSAA Assistant Director

Proposal: The OCF recommending NYSPHSAA allow schools to use a School Based Official (SBO) with the following criteria. This would be a <u>two-year pilot program</u>.

- * The SBO would only work non-varsity games
- * SBO will be paid based on the Section's Officials contract
- *SBO will be certified through the local chapters training and testing protocols
- *Assignments will be offered to all members of the local chapter and if non-varsity game remain unassigned then the assigner will contact the SBO
- * SBO will not have to pay the local or state dues (excluding insurance and assignor fees) in the first year. SBO will be required to pay full dues starting in year two.

Effective start date: Fall 2021

Rationale: This recommendation will help address the issues lack of official's and sub-varsity games not being covered by one or more officials.
